



**Over 550 Community and Economic Development, Health Care, Education, Local Government and Entrepreneurship Groups Urge New Focus on Rural Community Competitiveness and Investment as part of 2007 Farm Bill.**

As debate continues on the 2007 Farm Bill, over 25 national organizations have joined to form the Campaign for a Renewed Rural Development, chaired by the Immediate Past President of the National Association of Counties. This diverse group of organizations is committed to providing a voice to the needs of Rural America in the Farm Bill debate.
